**SURFACE PREPARATION:** NEW CONCRETE: Remove all dust, dirt, grease and other foreign materials. For maximum adhesion, acid etching may be required. Surface must be thoroughly dry before application of sealer. METAL SURFACES should be cleaned by solvent degreasing. WOOD SURFACES: Remove all dust, dirt, grease and other foreign materials.

**PRIMER:** Use three parts 1015-WRU/one part P31T

**APPLICATION TEMPERATURE:** Do not apply when surface temperature is below 50 deg. F. Surface moisture content of concrete should be no greater than 18%.

**CURE TIME:** Eight hours light traffic - 36 hours heavy traffic, 70 degrees F., 50% R.H. To recoat: Two to six hours between coats.

**APPLICATION:** One to three coats are recommended for this system, depending on porosity of surface and penetration. Apply brush, spray or 3/8" roller. Do not over roll or product gassing could occur.

CLEAN UP: Clean up all spills and tools immediately with P32T Thinner or lacquer thinner.
