**SURFACE PREPARATION:** Sandblast recommended. Surfaces must be clean, dry and free of dirt, dust or chemical contamination.

PRIMER: Steel: Parker 300 Universal Primer

Concrete: Parker 26-CP Prime Coat

**RECOMMENDED THINNER: P35T** 

**MIXING:** Mix Part "A" into Part "B" for approximately five(5) minutes. Allow approximately 30 minutes for induction time before application. Temperature of coating and substrate should be 60-70 degrees F.

**APPLICATION:** Apply brush, roller or spray. Use Binks #18 spray gun, 66 tip, 66PE or 63PB nozzle or equal. Airless Spray: Use of spray tips with .015-.019 orifice is suggested. Back roll for maximum substrate penetration when spray applied.

**CURE TIME:** Two(2) to eight(8) hours depending on temperature

**CLEAN-UP:** Lacquer Thinner, M.E.K. or P35T
